

# **LICENSE TERMS FOR MUNCY'S PLAT PRONTO FOR MICROSOFT WINDOWS**

These license terms are an agreement between you and the application publisher, B.W. Muncy, Inc. Please read them. These license terms apply to the application, Muncy's Plat Pronto. Licenses for Muncy's Plat Pronto can be purchased and downloaded from the Microsoft Store. These terms also apply to any updates or supplements to Muncy's Plat Pronto which, if available, may be downloaded from the Microsoft Store.

**BY DOWNLOADING OR USING MUNCY'S PLAT PRONTO, OR ATTEMPTING TO DOWNLOAD OR USE MUNCY'S PLAT PRONTO, YOU ACCEPT THESE TERMS. IF YOU DO NOT ACCEPT THESE TERMS, YOU HAVE NO RIGHT TO AND MUST NOT DOWNLOAD OR USE MUNCY'S PLAT PRONTO.**

- 1. LICENSE.** Muncy's Plat Pronto is licensed, not sold. You are granted a single user nonexclusive, nontransferable license to use the application and the documentation known collectively as "Muncy's Plat Pronto" in accordance with the conditions and terms herein. This agreement only gives you some rights to use Muncy's Plat Pronto. If Microsoft disables the ability to use Muncy's Plat Pronto on your devices pursuant to your agreement with Microsoft, any associated license rights will terminate. B.W.
